- Current membership in IPRA
- Served at least ten years as a full-time park and recreation professional
- Meets a minimum of five of the following:
 - Current or former officer or member of IPRA Board of Directors
 - Current or former chairman of an IPRA committee
 - Contributor of articles for handbooks, newspapers or magazines in the interest of parks and recreation, or author or co-author of one or more books related to parks and/or recreation
 - Presenter of workshops or other continuing education activities related to parks and recreation
 - Contributor of recognizable achievements and service within the candidate's local community
 - Major contributor to the park and recreation profession
 - State certified through IPRA as Certified Park & Recreation Professional, Associate Park & Recreation Professional, Provisional Park & Recreation Professional, or Retired Park and Recreation Professional
